## The HME Market By The Numbers

# New data can't come fast enough

This year's State of the Industry Report reflects data from 2016 and, as you know, 2016 was, by all accounts, a tough year for the HME industry, possibly the toughest yet.

The main reason for that: CMS rolled out the competitive bidding program nationwide. The rollout occurred in two waves, the first on Jan. 1 and the second on July 1. (The second wave, as you also know, was retroactively delayed until Jan. 1, 2017, but for the purposes of this report, let's keep the picture as simple as possible.)

This is the likely reason that we see the growth in allowed charges for DME drop to \$5.5 billion in 2016 (see page 7). This is a particularly tough pill to swallow after a series of small rebounds in 2014 (from \$5.3B in 2013 to \$5.8 billion in 2014) and again in 2015 (from \$5.8 billion in 2014 to \$6.3 billion in 2015). Growth in oxygen and supplies took the largest hit in 2016, from roughly \$1.5 billion in 2015 to roughly \$1 billion in 2016.

Not even the nationals were immune from competitive bidding's claws in 2016. While Lincare still took the No. 1 spot on our list of top Medicare providers (see page 15), the amount it was allowed dropped from \$830.9 million in 2015 to \$651.8 million in 2016. Ouch.



Another national that we keep an eye on is Apria Healthcare, which dropped from the No. 3 spot to the No. 4 spot in 2016 with \$224.3 million vs. \$273.5 million. Another national dropped out of, not the top 10, but the top 15 completely: American HomePatient. In 2015, it had \$75.2 million in the No. 13 spot; in 2016, \$57.2 million in the No. 23 spot.

As one would expect, when you cut reimbursement so drastically that it affects access, utilization was down nearly across the board (see pages 12-14).

In the mobility product category, there were a few more positives, like the K0861 power wheelchair with a nearly 17% increase in utilization from 2015 to 2016. There are a number of things working in providers' favor when it comes to mobility, including a carve out from competitive bidding for complex rehab codes, and a prior authorization demonstration process for standard mobility in 19 states through 2018, and a prior authorization process for two complex rehab codes, K0861 and K0856, that started earlier this year.

2016 is done, thankfully. And hopefully 2017 will be another year altogether.





**BETOS STANDS FOR BERENSON-EGGERS TYPE OF SERVICE**, and it's the name of a coding system developed to analyze the growth in Medicare expenditures. The coding system covers all HCPCS codes; assigns a HCPCS code to only one BETOS bucket; consists of readily understood clinical categories that permit objective assignment; is stable over time; and is relatively immune to minor changes in technology or practice patterns.


